INTERNAL TRANSFER APPLICATION

DMD is a selective program. Application for internal transfer into the program will be considered at the end of each academic semester, though freshman must complete 8 CUs at Penn prior to application. Applications are due by Dec. 15th for spring admission and May 15th for fall admission. Your GPA is not the only factor the DMD transfer committee will look at. We will also take into account your academic rigor while at Penn, and the quality of your DMD essay.

Eligibility

If you are a Penn student in one of the four undergraduate schools, you are eligible to apply at the end of your freshman year (that is, after two semesters at Penn). While pursuing a dual degree is possible, it is not recommended.

Academic Requirements

You must have a cumulative GPA of 3.3 or higher. You must have completed at least eight Penn course units.

You must resolve any open grading issues (Incompletes, NRs, GRs) before applying.

Course prerequisites

In addition to the above requirements, you must successfully complete the courses listed below before we can consider your application. Note that you can use "Penn-equivalent credit", such as AP credit, course waivers, credit issued for departmental exams, or transfer credit from other institutions to fulfill a number of these requirements: MATH 1410, PHYS 0150, CIS 1100 and/or CIS 1200, CIS 1600, and a Fine Arts course at Penn (FNAR 0010, DSGN 1030, or DSGN 0010 are recommended).
